TITLE: A RESOLUTION AUTHORIZING THE EXECUTION OF A SHARED SERVICES AGREEMENT WITH THE COUNTY OF BERGEN FOR THE SHORT-TERM RENTAL AND UTILIZATION OF A STREET SWEEPER

WHEREAS, N.J.S.A. 40A:65-1, et. seq., known as the “Uniform Shared Services and Consolidation Act,” authorizes two or more local units to enter into an agreement for shared services known as a Shared Services Agreement (the “Agreement”) for the provision of any municipal services each participating local unit is empowered to provide or receive within its own jurisdiction as set forth under N.J.S.A. 40A:65-7(4); and

WHEREAS, the Borough of Demarest (the Borough”), provides street sweeping services to the Borough’s roads throughout the year to maintain clean roads within the Borough; and

WHEREAS, the County of Bergen owns certain equipment, including a 2006 Elgin/Pelican 3-wheel broom street sweeper that is used to sweep streets, which it makes available to municipalities within Bergen County for short-term rental use; and

WHEREAS, the Parties wish to enter into a Shared Services Agreement which governs the terms of rental for the County’s Street Sweeper in advance of the Borough’s need to utilize the equipment for use to clean the Borough’s roads, when needed; and

WHEREAS, the Parties have a pre-existing Agreement for these services that has been a success, which is set to expire; and

WHEREAS, the Borough has reviewed the proposed Agreement, a copy of which is attached hereto, and finds it to be in the financial best interest of the Borough to pursue; and

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Demarest, County of Bergen, State of New Jersey, as follows:

1. The Borough endorses the undertaking of a Shared Services Agreement with the County of Bergen for the rental and utilization of the County's Street Sweeper pursuant to the terms of the Agreement.
2. The Mayor, Borough Administrator and or their designee(s) shall hereby be authorized to take all legal and necessary actions to facilitate the Borough's participation in this Agreement.
3. The within Resolution and subject Agreement shall be maintained on file and available for public inspection in the office of the Borough Clerk.
4. A copy of this resolution shall be forwarded to the Division of Local Government Services pursuant to N.J.S.A. 40A:65-4(b).
5. This Resolution shall take effect immediately upon passage and publication in accordance with the law, if required.
